



Child Protection Enhancements (External)

The following enhancements to CMS will take effect on **20 June 2024**.

Related Orders Display

When a subcase (application) is filed that requires the selection of an existing order on the case, the related hearings panel will now only display the following order types that are in **Original** status (ie orders that are current):

- Interim Accommodation Order
- Family Preservation Order
- Family Reunification Order
- Care by Secretary Order
- Long-term Care Order
- Permanent Care Order
- Undertaking (Common Law)
- Undertaking (s272)
- Undertaking (s278)
- Temporary Assessment Order
- Therapeutic Treatment Order
- Therapeutic Treatment Placement Order



Interim Accommodation Order – Undisclosed Placement and Change in Service Provider

New options have been added to the IAO to allow for updates to *undisclosed placement* or *service provider* **within an extension**.



Subcases will now always display *Date of filing* (previously only displayed for migrated cases).





Interim Variation of Family Reunification Order

A new Interim Variation option added to Application Order (APP) to make it clearer that the FRO is being varied on an interim basis.

In addition, a new validation has been added to ensure an adjournment order (ADJ) is made if Interim Variation is selected.
